
On January 22, 2024, Hospital



#### Methodology Considerations

- Measurement year: 2021
- All statistics are limited to the 11 counties that had at least 5,000 unique patients residing in each county and had one or more HSHS-Prevea Health service.
- A patient may be counted more than once if a patient received a service in more than one type of facility from the same provider organization or received a service from more than one provider organization.
- Clinic visits include new and established patient visits only and does not include other services like laboratory services provided at a clinic.
- Clinic visits do not include chiropractic, dental, vision, or public health services.
- Procedures include all procedures (except laboratory blood draws) performed at all types of facilities (e.g., hospital, ambulatory surgery center, urgent care, clinic).
